## **Points of interest from the last meeting** 1. Subs By Installment in advance

The Secretary outlined the **Subs By Installment** plan that the club decided to adopt at the last meeting and distributed booklets of deposit slips. This enables members to pay their subs by installment in advance for the next financial year up to any amount that is convenient. For example if a member decides to pay \$20 per month or thereabouts and pays 8 installments he will have a credit of \$160 by the time the fees are due. The member fills out the deposit slip and receipt butt and hands to Secretary or Treasurer who signs the receipt butt.

## 2. Strategic Plan

Graeme Allen to compile. Graeme requested a note in the next newsletter asking members for their ideas regarding the direction they see the club taking and what the club should strive to achieve.

Action: Graeme Allen to put together Strategic Plan.

Action: Editor to put a note in next newsletter asking for input from members.

## 3. Life Member Protocol

Due to lack of room in the last newsletter to print the revisions arising from the last meeting this item was held over until the next meeting.

## 4. Field Maintenance

a) Fencing

As reported in the last newsletter a 50m fence has been erected between the buildings and the pit area. It was decided at the field by the members present when the fence was erected to construct an 'L' shaped fence enclosing all the buildings. Max Rowan reported that he has discussed the proposal with the Landlord and it is okay. The meeting requested Max to proceed based on the costs of the 50m fence. It is estimated to be around \$500. The fences will better define the car park, controls spectator movement and will also keep the sheep out thus enabling the trees to grow.

There was some discussion regarding the wording of the warning sign to be attached to the fence. We finished up with *Restricted Area* – *No spectators beyond this point*.

## b) Tank overflow

Roger Carrigg pointed out that the water tank requires an over flow pipe to direct the over flow away from the back of the shed.

Action: Glenn White to get plumbing fittings and oversee job.

## c) Water leaks

Roger Carrigg also pointed out that the water leaks in the container and site hut need fixing. It was generally agreed that a roof needs to be erected over the container. The site hut servery window needs better flashing.

#### Action: Max Rowan to look at site hut window seal.

## d) Trees

Murray Anstis reported that he has some trees to plant. It was agreed that once the enclosing fence is erected the trees can be planted. (The landlord stipulates trees indigenous to the area only)

## e) Rocks

Peter Barnett sadly informed us that he recently hit the pile of rocks in the out field during a dead stick landing causing considerable damage. (Bad luck Pete) Graham Waterhouse and Tom Jobling offered to remove then next week.

## Action: Graham Waterhouse and Tom Jobling to remove the rocks.

## 5. Annual Display – Date Clash

The Secretary stated that he has contacted John Lamont to see if the VFSAA can move the round of the VFSAA competition at Keilor so that it doesn't clash with our annual display scheduled for 28<sup>th</sup> March 2004. John has agreed to our request and is awaiting confirmation from the Keilor club.

## 6. Financial Members

The Secretary made the members present aware that unfinancial members are NOT able to fly until their fees are paid.

#### 7. Jackets and Badges

#### 8. Sausage Sizzles

The Secretary stated that we have received the Council permits for our two sausage sizzles planned for the calendar year. The first one is on Saturday 27<sup>th</sup> September at Safeway Sebastopol which is the weekend after the next meeting. We will need a show of hands at the next meeting.

#### 9. Roy Gladman Round 2

## New Models seen at field

The first weekend in September proved to be one out of the blue, after all the bad weather we have had Fathers day turned out to be great flying conditions.

Max has put a lot of work into his latest project, a nice Pitts Special. The model has a wingspan of around 57" and is Powered by a G.M.S. 120 two stroke motor. The model doesn't look big enough to take an engine of that size but looks can be deceiving!

After some time fiddling with the motor (2hrs or more), the Pitts was deemed ready for its maiden flight. The model seemed to taxi nicely with no tendency to nose over, it was pointed into wind and with the throttle fully opened flying speed was reached within 10 meters. Model rotated without any problems and soon gained a safe height; Max didn't have to do much trimming and the model behaved nicely. Having done four or five circuits Max had a problem with the motor, after throttling off it just refused to pick up again with no alternatives a landing had to be made. There was no time to set up a nice long approach as one would like on a models first landing, instead Max had to get the Pitts down as soon as possible as it was fast loosing air speed. Making a hurried approach

Max misjudged the models speed and with no throttle it got a little too slow and stalled onto the runway. Landing heavily some minor damage was done to the landing gear. All in all it was a good test flight and it looks like the Pitts will be a great model.

P.S. Do you know anyone with a good 120 two stroke for sale!!

On the same day Glenn brought out his GAF Nomad which is powered by two Yellow Jacket 0.15's running 8x4 props. As the motors were brand new and had never fired a shot the main purpose of the day was to see how the motors would run. There were no problems when the motors were run separately but a major problem arose when both motors were running. A harmonic vibration set in they had to be stopped which meant there could be no test flight. We think the solution will be to change the plywood engine mounts to aluminium. Stay tuned!

Tom arrived later in the day with another trainer. This one came from his next door neighbour for a song. It is powered by an OS 40 and came complete with receiver and servos. Roger test flew the model and it flew exceptionally well. Good buying Tom! During the test flight, Roger gave Tom the Tx and he had several uneventful circuits.



## **Crash Report**

It seems that we missed one or two crashes in last month's newsletter (thought you got away with it didn't you?). When you go out flying mid-week it takes a little longer for the news to filter through. Graham Waterhouse, Ray Clarke and Peter Barnet all had mishaps.

Peter had a dead stick landing and was unfortunate to find the only pile of rocks in the paddock. The wingtip hit one of the rocks, spun his model and did some damage, which we hear has since been repaired.

**BRMFC MEMBERSHIP** – Report by Tom Jobling (Amended by Roger Carrigg from minutes of June 2003 meeting)

#### Introduction:

A need exists to formalise the terms and conditions of membership to the BALLARAT RADIO MODEL FLYING CLUB Inc. (BRMFC Inc). Membership of any club or group should be an honour and privilege which precludes any such member from bringing the group or its activities into disrepute. In this respect the BRMFC is no exception.

## 1. Types of Membership:

Various types of membership are necessary to allow the club to function and the members to have a fair voice on matters that may affect their activities or functions within the club. Public liability Insurance is essential for a person to fly a model aircraft at the club designated flying field.

## a. Senior Member

A Senior member is a person over the age of 18 years that is accepted into the club as a modeller and/or pilot. A senior member shall pay all fees levied by the club for membership and pay the prescribed MAAA Insurance Levy. A senior member may fly model aircraft unrestricted at the clubs' designated flying field. A senior member shall have full voting rights at any meeting convened by the elected committee of management.

#### b. Junior Member

A Junior member is a person under the age of 18 years that is accepted into the club as a modeller and/or pilot. A junior member shall pay all fees levied by the club for junior membership and pay the prescribed MAAA Insurance Levy. A senior member must always supervise a junior member while exercising the right to fly a model aircraft at the clubs' designated flying field. A junior member shall have full voting rights at any meeting convened by the elected committee of management.

#### c. Associate Member

An Associate member is either a Senior or Junior member and already belongs to another VMAA affiliated club. The associate member pays the prescribed MAAA Insurance Levy through the other club. Proof of membership is required by way of the MAAA card. The associate member has all the rights of the Senior or Junior member category.

#### d. Social Member

A Social member is a person that is accepted into the club but does not wish to fly a model aircraft. A social member shall pay all fees levied by the club for senior or junior membership. No insurance levy is required. A social member shall have restricted voting rights at any meeting convened by the elected committee of management. These restrictions shall apply to all matters directly affecting the flying of model aircraft and flying field safety.

#### e. Family Member

The club may permit a family group to apply for membership. All persons so accepted shall fill one of the other designated membership identities. The club may apply such special membership fees as determined at a general meeting of members for family membership. The prescribed MAAA Insurance levy must be paid for any family member intending to fly a model aircraft at the clubs' designated flying field.

#### f. Honorary Member

The club may accept the nomination of a person as an honorary member. An honorary member shall have all the rights of a senior member. An honorary member shall not be required to pay any club membership fee. However, should the honorary member wish to exercise the right to fly a model aircraft at the clubs' designated flying field, then that honorary member shall become liable for the prescribed MAAA Insurance Levy.

#### g. Life Member

The club may accept the nomination of a person as a life member. A life member shall have all the rights of a general member. A life member shall not be required to pay any club membership fee. However, should the life member wish to exercise the right to fly a model aircraft at the clubs' designated flying field then that Life member shall become liable for the prescribed MAAA Insurance Levy.

#### 2. Gaining Membership:

- a. Any person may gain membership of the BRMFC within category a) to e) by being nominated by an existing member, completing the membership application form and paying the appropriate fees and MAAA Insurance Levy.
- b. A member may nominate a person to be a Social Member. Such a person should have a general interest in aeromodelling. A social Member is required to pay the Club annual subscription. Should a Social Member decide to

engage in club flying activities then the Social Membership status shall be altered to reflect that decision, eg. Social Member becomes a Senior or Junior Member.

- c. A club member may nominate any person to be admitted as an Honorary Member. Such nomination shall be accompanied by a written proposal detailing the special attributes the nominee would bring to the club. An Honorary Member may be a member of another club, or a prominent person who would bring defined expertise to the BRMFC. An existing member of the BRMFC may also be nominated. That member should have performed exemplary duties within the club. For example, a member who has continuous membership in excess of 10 years and has served for at least four years in an executive position could be eligible for Honorary Membership nomination. To be accepted as an Honorary Member the nomination must be presented at a general meeting; debated and carried at the following general meeting by over 50% of the club membership. Nominator would need to lobby members to attend meeting to gain required votes.
- d. Any BRMFC member may nominate another BRMFC member to be given Life Membership of the club. A Life Membership nomination shall be a written statement showing good cause to why a Life Membership should be granted. Good Cause may include such issues as:
  - i. Extensive service to the club over a minimum of 10 years.
  - ii. A specific incident, where Life membership would be an appropriate reward.
  - iii. Long and faithful membership and service to the club, including executive service. This category of Good Cause would probably apply to an ageing member as reward.

To be accepted as a Life Member the nomination must be presented at a general meeting; debated and carried at the following general meeting by over 50% of the club membership. Nominator would need to lobby members to attend meeting to gain required votes.

- e. Conditions applying to Honorary and Life Membership include:
  - i. Total Honorary and Life Members shall not exceed 10% of other Club Membership.
  - ii. Honorary Membership shall be reviewed annually, at the monthly general meeting following the Annual General Meeting.
  - iii. (Need to establish a clause that defines where a member is non active for a specified period of time the life membership is revoked.)

## 3. Expulsion:

A member of any category may be expelled from the club membership by a unanimous vote of all members present at a general meeting. A motion for expulsion must be made in writing to the BRMFC Honorary Secretary not less than seven days before a general meeting. The motion shall contain all relevant information referring to the request for expulsion.

Cause for expulsion may be any act or behaviour that brings the BRMFC or aeromodelling in general into disrepute.

The elected Executive may suspend a member of any category immediately, pending investigation of a report of an act or behaviour that is considered to have the potential to bring the BRMFC into disrepute.
